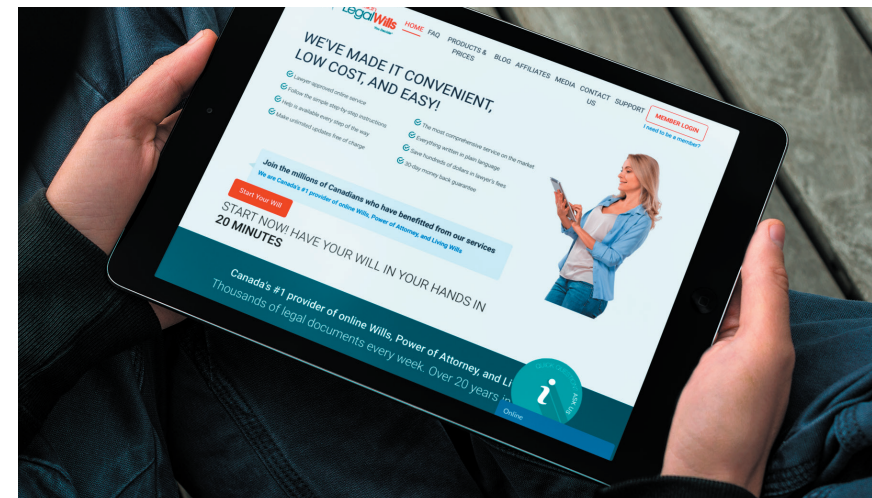


NEW SERVICE: MyClients


