They were a mixed group; some had children, some owned a house, some were married, but what they all had in common was that they all had decent jobs and all knew they needed a Will, yet not one of them had one. It seemed like a broken system, and this got Henry and Tim's wheels turning. They started meeting with a number of lawyers to see if there was potential for a more convenient, affordable solution, and LegalWills was born. Our first Will service went online in 2001, and the service has been expanded and improved every year for over two decades.

ABOUT WILLS

- » 62% of Canadian adults still do not have a Will and an additional 12% of Canadians noted that while they did have a Will, it was out-of-date.
- » It is important for every Canadian adult to have a Will, regardless of age or the value of assets.
- » It is common for people to assume that when they die, everything will automatically go to their spouse. If you have children, this only happens in Alberta and Manitoba. Every other province distributes an estate between a spouse and children. This can often result in a family home being sold off in order to create the required shares.
- » If you are living common-law, only some Provinces recognize this relationship regardless of duration. For example, in Ontario dying without a Will in a common-law relationship gives the surviving partner nothing.
- » If you have minor children and both parents are involved in a common accident, your children are put in the care of guardians. Hopefully you will have family members who put themselves forward as candidates. Ultimately, a judge will decide on the most appropriate guardian from the selection of applicants.
- » Working with a lawyer to make a Will can cost you hundreds of dollars. This is why online Will services, where making a Will for an individual typically costs \$100 or less, are becoming an increasingly attractive and affordable option for Canadians.
